## **Centrum Pro Bono** (<a href="http://www.centrumprobono.pl/en/">http://www.centrumprobono.pl/en/</a>)

The Centrum Pro Bono serves as clearinghouse and was established to meet legal needs of NGOs in Poland. Professional legal services are something very few of the NGOs can afford. The Centrum Pro Bono therefore helps to link NGOs with law firms willing to provide pro bono legal services. The Centrum is intended to serve NGOs only (not individual clients) in matters concerning their operational issues (such as statutes, taxes, civil and commercial contracts, administrative law, employment issues etc.) Centrum Pro Bono transmits requests of NGOs for pro bono legal services to law firms. Law firms are offered a list of issues from which they can choose pro bono request best suiting their fields of specialization and the company's image. The Centrum Pro Bono is managed by the Legal Clinics Foundation, however its initiators were four non-governmental organizations the University Legal Clinics Foundation, the Ashoka Foundation, the Helsinki Foundation of Human Rights and the Public Interest Law Institute.
